Capital District received \$1,564,829 in an FY24 VOCA allocation. All FY24 VOCA requests have been received and were presented at the meeting. Capital District received a total of 21 Notices of Intent for a total of \$2,319,633 in requests. The Board discussed funding as presented on the attached spreadsheet. A motion was made by Mr. Rusty Fornea and seconded by Captain Tommy Favaron. The motion carried by call of roll call vote with the following abstaining from voting on their respective agencies: Ms. Tracey Barbera - 19<sup>th</sup> Judicial District Attorney's Office; Mr. Brad Cascio – 21<sup>st</sup> Judicial District Attorney's Office; Mr. Scott Perrilloux - 21<sup>st</sup> Judicial District Attorney's Office; Mr. Rusty Fornea – Adapt, Inc.; Mr. Rob Carlisle – Child Advocacy Services, Inc.; Sheriff Gerald Sticker – Tangipahoa Parish Sheriff's Office.

Capital District received \$82,385 in an FY23 JJDP allocation. Two FY23 JJDP Notices of Intent were received. One new request was received from the Louisiana Center for Children's Rights. Youth Service Bureau of St. Tammany applied for a consecutive year and is eligible to receive for three years total. The board approved Youth Service Bureau of St. Tammany to continue funding for the Washington Parish Delinquency Program. A motion was made by Mr. Rusty Fornea and seconded by Captain Tommy Favaron. The motion carried by call of roll call vote.
